## **BASES VII ARTIST BOOK AWARD CIUDAD DE MÓSTOLES 2022**

The City Council of Móstoles through the Department of Safety, Coexistence, Culture and Ecological Transition announces the VII Edition of the Artist Book Award Ciudad de Móstoles in order to promote and encourage artistic creation.

### **1.- Participants**

Any artist over 18 years of age, of any nationality may attend. Móstoles City Council workers are excluded from this call.

### **2.- Works**

Each artist will be able to present a work, with a free theme.

The work may be presented in any of the possibilities of the artist's book, not exceeding 30 cm on any of its sides.

Works that contain perishable elements or that are made with materials that may be considered dangerous will not be accepted.

### **3.- Data and documentation**

It will be enclosed in an envelope, along with the work forwarded: the registration form, the technical file of the work and the artist's curriculum vitae, as well as a photocopy of the DNI/Passport, residence card or similar, and an image of the work presented.

Only in the event that the work is delivered by hand must the so-called form be completed.

If necessary, a description of the assembly and its specifications must also be included, providing the necessary elements for its correct presentation.

### **4.-Delivery of the works**

The period for receiving works in hand will be held from 5<sup>th</sup> to 10<sup>th</sup> September at the Centro Cultural Villa de Móstoles, Plaza de la Cultura, s/n, Móstoles, from 10 a.m. to 14 p.m. and from 17 p.m. to 21 p.m. from Monday to Saturday.

The works sent by post can be forwarded from the moment these bases are published until the 10<sup>th</sup> September to the following address: Premio Libro de Artista, Centro Cultural Villa de Móstoles, Plaza de la Cultura, s / n, 28931 Móstoles, Madrid, España.

All works will be delivered or shipped duly packed and ready to be exhibited.

The work will be presented ready to be exhibited.

Packaging and transportation costs are borne by the participants.

### **5.-Awards and valuation**

4 prizes of 2,000 Euros each will be awarded.

For the evaluation of the awards, the jury will take into account the criteria of: originality, aesthetic expression, composition, creativity and technical procedures as a whole, and will decide

which works are awarded, a record is drawn up where the amounts corresponding to each work and its author will be listed.

The payment of the prizes will be made by bank transfer.

The winners must prove, in a responsible declaration, that they are not involved in any prohibition to hold the status of beneficiaries and that they are up to date with their tax and social security obligations. The amounts are subject to current tax legislation, and the legally established withholdings are made on them, in accordance with the Personal Tax Regulations.

The winning works will become part of the Artistic Heritage of the Móstoles City Council. Likewise, and in accordance with the provisions of the Intellectual Property Law, the authors assign to said City Council, exclusively, all the economic rights to exploit the works.

## **6.- Jury**

The Jury will be made up of people of recognized prestige in the artistic world who are specially qualified. It will act with the maximums of freedom and discretion, and will have, in addition to the normal powers to issue the ruling, those to interpret, in accordance with the organization, these rules.

The ruling will be final and will be made public at the opening ceremony on 20<sup>th</sup> November at 12 noon.

If the winners do not attend this event, they will be notified of the resolution by email.

## **7.-Exhibition**

An exhibition with the selected works will be held from 20<sup>th</sup> November 2022 to 22<sup>nd</sup> January 2023 in Hall 1 of the Villa de Móstoles Cultural Centre. The works exhibited will be insured during the exhibition period.

The organization, although it will take into account the artist's indications, will ultimately decide how the selected works are displayed.

Due to the characteristics of this format, the exhibited pieces may be manipulated by visitors. Gloves will be left in the room for this purpose. The possible deterioration that the work may have due to this manipulation cannot be claimed either from the insurance company or the organizing institution.

Participants must assign the Móstoles City Council the rights of reproduction, distribution and public communication for said exhibition as well as for the edition of the commemorative catalogue. Rights contained in articles 17 and 21 of the Consolidated Text of the Intellectual Property Law, according to Royal Legislative Decree 1/1996 of April 2 and modification of Law 5/98 of March 3, without any consideration.

## **8.-Return of works**

The works not selected for the exhibition may be picked up by hand from 24<sup>th</sup> to 30<sup>th</sup> November at the Villa de Móstoles Cultural Centre, Plaza de la Cultura, s / n, 28931 Móstoles, from 10 a.m. to 2 p.m. and from 5 p.m. to 9 p.m. on Monday to Saturday and from 10 a.m. to 2 p.m. on Sunday.

The selected works may be withdrawn by hand from 27<sup>th</sup> to 31<sup>st</sup> January at the time and place indicated above.

After this period, if any of them has not been withdrawn, it will be understood that the author has voluntarily renounced ownership of it.

The works whose artists decide to be returned by courier will be made postage due from 14<sup>th</sup> February.

The return of works by post will be made in the case of those not selected from 1<sup>st</sup> December, 2022 and in the case of those selected from 13<sup>th</sup> February, 2023.

### **9.-Other specifications**

The organization will make every effort to take care of the works received, but will not be liable for damages that may arise from transport.

Participation in this Award implies full acceptance of the bases, and these may be modified if the City Council of Móstoles considers it necessary.

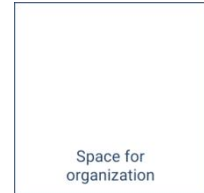

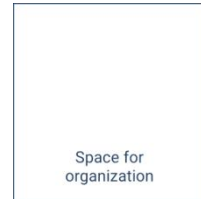

## APPENDIX 1

### Information on data protection

As established in the current data protection regulations, you are informed that the data provided by the participants will be processed by the City Council of Móstoles (NIF: P2809200E), in order to process and manage the Artist Book Award Ciudad de Móstoles. The legality of the treatment is based on article 6.1.e) of the RGPD: the treatment is necessary for the fulfilment of a mission carried out in the public interest or in the exercise of public powers conferred on the person responsible for the treatment: Law 7/1985, of 2<sup>nd</sup> April, Regulator of the Bases of the Local Regime.

The data may be published on websites, the media and social networks, and may also be transmitted to other third parties as long as there is a legal obligation.

The data will be kept for as long as necessary to fulfil the purpose for which it was collected and to determine the possible responsibilities that may arise from said purpose and from the processing of the data.

Affected persons may exercise the right to:

- Obtain confirmation as to whether the Móstoles City Council is treating your personal data.
- Access your personal data, as well as request the rectification of inaccurate data or, where appropriate, request the deletion when, among other reasons, the data are no longer needed for which they were collected.

Request in certain circumstances:

- The limitation of the processing of your data, in which case they will only be kept by the Móstoles City Council for the exercise or defence of claims.
- Opposition to the processing of your data, in which case the Móstoles City Council will stop processing the data, except for compelling legitimate reasons, or the exercise or defence of possible claims. Including the processing of your data for automated individual decisions.
